The purpose of this letter is to provide you with updates related to our school district.

Our last food service pick-up for the summer will be Monday, June 29th from 10:30 a.m. – 12:30 p.m. Due to scheduled vacations, please note there will be limited office personnel available during the week of June 29th. Additionally, there will be no weekly communication sent out by the school district next week. Weekly communications will resume beginning on Thursday, July 9th at 12:00 p.m.

At our board meeting on June 22nd, the Board approved our preliminary [Athletics Health and Safety Plan](#) for organized volunteer activities from July 6th through August 9th.
