Dear Muncy Family,

I hope this letter finds you and your family in good health.

The purpose of this letter is to make you aware of approved items from Monday evening's board meeting.

First, the Board approved several changes to the [2020-2021 school district calendar](#). The following dates were added as Distance Learning Days for all students: (a) Monday, October 26th; (b) Friday, November 6th; (c) Friday, December 11th; and (d) Friday, January 29th. The district will provide transportation from the high school to LycoCTC for students to attend LycoCTC on all distance learning days. Students may also arrange for their own transportation to LycoCTC on distance learning days or students may log into their LycoCTC classes via Google classroom.

If possible, we encourage everyone during the next two distance learning days (October 26th and November 6th) to complete as much work as possible during the regularly scheduled school day to ensure you are able to access and submit all necessary information within a distance learning format. If you are in need of a hotspot to participate in distance learning activities, please e-mail or call Linda Kneedler at lkneedler@muncysd.org or 570-546-3125 ext. 2040. If you are experiencing technical issues with distance learning activities, please e-mail Steve Haddon at shaddon@muncysd.org.

Additionally, the following dates were added as Act 80 days for teachers and will now be considered a holiday for all students: (a) Tuesday, November 24th (extends Thanksgiving Break by one day); (b) Wednesday, December 23rd (extends Winter Break by one day); and (c) Friday, January 15th (extends Martin Luther King Jr. Holiday Weekend by one day).

Second, the Board approved several changes to [Muncy School District's Health and Safety Plan](#). Besides the changes made to the school calendar, the other main changes made to the plan included: (a) an added section on distance learning expectations, (b) an added section on tips to help your child with distance learning, (c) added thresholds and actions based on the number of cases of COVID-19 within a 14-day period in the same school building (previously sent in October 13th correspondence) and (d) added indoor / outdoor capacity calculations for various school district venues or spaces.

Thank you for your continued cooperation, flexibility and support. We will continue to keep you apprised of any additional updates in the future.

The continuity of our educational environment involves every individual working together to practice universal precautions as follows:

- **If sick, please stay home.** Please use the updated [symptom-screening tool](#) prior to having your child(ren) ride the school bus or attend school in the morning. Immediately seek medical advice/attention if one has symptoms of COVID-19.
- **Practice good hand hygiene** by regularly washing your hands, using hand sanitizer when unable to wash your hands and avoid touching your face and eyes.

- **To the maximum extent possible, maintain a physical or social distance from others.** If possible, try to maintain a physical or social distance of at least six (6) feet from others. If not possible, maintain as much physical or social distance as possible based on the circumstances.
- **Wear face coverings at all times with limited exceptions,** even when able to keep six feet apart. All face coverings need to cover both the mouth and the nose.
