Dear Muncy Family,

I hope this letter finds you and your family in good health.

First and foremost, I want to thank everyone for your cooperation, flexibility and support this week and, most importantly, for keeping the focus on teaching and learning in our classrooms.

The Muncy School District Board of Directors will hold a Special Meeting on Monday, September 13th at 7:00 p.m. in the high school auditorium to allow for a more complete discussion of the Order in relation to the District's Health and Safety Plan, to listen to public input and to examine what, if any, options may be available to the Board for consideration.

Please enter the high school through the Schuyler Avenue Entrance or Bus Lobby Entrance. These are the same two entrances students use to enter the high school in the morning. The doors to these entrances will be unlocked at 6:30 p.m. All other entrances will remain locked.

As you enter, you will be asked to sign in. The sign in sheet will ask for your name, physical address, municipality (Muncy Borough, Muncy Creek Township or Muncy Township, Non-Resident) and whether or not you wish to make public comment. The sign in sheet will then be used to assist in recognizing individuals to speak during the public input portion of the meeting. Masks will be available at each entrance for all individuals attending the meeting.

Muncy School District is committed to providing a safe meeting environment for all who plan to participate in the meeting. Everyone who decides to provide public comment should be able to express their viewpoints to the Board without interruption. Similarly, outside of public comment, the Board needs to be able to conduct their business without interruption. In order to help facilitate a safe meeting environment for all, the Board will follow the procedures identified in Board Policy #903 – Public Participation in Board Meetings.

- Participants must be recognized by the presiding officer. All statements shall be directed to the presiding officer and not addressed to Board members individually.
- Public comment will be limited to residents of Muncy School District. All individuals wishing to provide public comment should identify themselves by name and physical address including whether they live in Muncy Borough, Muncy Creek Township or Muncy Township.
- Each statement made by a Muncy School District Resident shall be limited to three (3) minutes in duration.

- The Board shall not hear personal complaints against any person connected with the school district.
- No placards or banners will be permitted within the meeting room.
- Questions requiring investigation will be referred to the appropriate administrator for later reporting to the Board.
- The presiding officer is responsible for maintaining proper decorum, and adhering to any established time limits. The presiding officer may:
 - Interrupt or terminate a participant's statement when the statement is too lengthy, personally directed, abusive, obscene, or irrelevant.
 - Request any individual to leave the meeting when that person does not observe reasonable decorum.
 - Request the assistance of law enforcement officers to remove a disorderly person when his/her conduct interferes with the orderly progress of the meeting.
 - Call a recess or adjourn to another time when the lack of public decorum interferes with the orderly conduct of the meeting.

I look forward to a productive meeting on Monday evening. I am confident we will all continue to work together to make the 2021-2022 school year great for all based on our Board's decisions.
