Dear Muncy Family,

I hope this letter finds you and your family in good health.

Over the course of the last 24 to 48 hours, the school district has received numerous updates from our students and families in relation to COVID-19. We cannot thank everyone enough for working together to help maintain the continuity of our educational environment.

We worked through the details of these updates with our local Department of Health (DOH) this morning. At this time, we have identified a total of two (2) confirmed student cases at Muncy Jr. / Sr. High school from over the break which require us to contact trace for Monday, November 23rd. Currently, we have identified zero (0) confirmed cases at the elementary school which require us to contact trace.

It is our understanding in discussing clarifications received from the Pennsylvania Department of Education with our local Department of Health (DOH) that our school closure for Thanksgiving Break resets our 14-day rolling window back to zero beginning Tuesday, December 1, 2020. Therefore, as a result of our time off from school, the cases identified over the break do not impact our current 14-day rolling window and our current status for both buildings is zero (0) cases.

We will continue to work with DOH to monitor all of the updates we receive and provide timely notification of confirmed cases that result in a direct exposure on school grounds or at school related events. We hope all of our students, families and staff impacted by COVID-19 have a quick recovery.

The continuity of our educational environment involves every individual working together to practice universal precautions as follows:

- **If sick, please stay home.** Please use the updated [symptom-screening tool](#) prior to having your child(ren) ride the school bus or attend school in the morning. Immediately seek medical advice/attention if one has symptoms of COVID-19.
- **Practice good hand hygiene** by regularly washing your hands, using hand sanitizer when unable to wash your hands and avoid touching your face and eyes.
- **To the maximum extent possible, maintain a physical or social distance from others.** If possible, try to maintain a physical or social distance of at least six (6) feet from others. If not possible, maintain as much physical or social distance as possible based on the circumstances.
- **Wear face coverings at all times with [limited exceptions](#),** even when able to keep six feet apart. All face coverings need to cover both the mouth and the nose. Face coverings should be worn by all individuals at all times while on school property.
